We believe that having a strong voice in order to speak out on issues such as changes to the Residential Tenancies Act, the City of Ottawa's request to the Province for increased taxing and other regulatory powers, properly targeted government investment in housing assistance, and the ongoing fight to reduce the unfair municipal property tax burden places on all multi-residential properties will help us to more effectively lobby for positive outcomes for all of these issues.

Changes in any of those areas could have a significant negative impact on our industry. If that were to happen, it would in turn drastically reduce the amount of work that we would be able to carry out on our properties, thereby reducing work for industry suppliers. As you can see, there really is a need for you to become involved with EOLO because the issues we are fighting for affect us all.
